PLEASE TAKE NOTICE that the Defendant Ronald E. Weinland, through undersigned counsel, consistent with the proceedings before the Court on May 30, 2012 regarding certain motions *in limine*, including the United States' second motion *in limine* [Record No. 35] to exclude the Defendant from offering into evidence a five minute segment of a 2002 recorded sermon, seeks to introduce only that portion of the 2002 recorded sermon transcribed in the transcript excerpt attached as **EXHIBIT A**. The excerpted portion comes from a sermon that the Defendant gave to church members on December 28, 2002 titled "Planning Ahead." The excerpted portion of the Defendant's sermon relates to the Defendant's discussion of putting church funds in a foreign account in his personal name.

The excerpted portion has a running time of approximately forty-eight seconds. The total running time of the 2002 sermon recording from which the excerpt was taken is approximately one hour and thirty-four minutes long. The Defendant has provided the United States with an audio recording of the entire sermon. The excerpted portion begins at approximately eighteen minutes and fifty-seven seconds into the audio recording of the sermon. The Defendant is

prepared to provide an audio copy of the entire sermon and/or the excerpted portion to the Court should the Court want to review the audio recording(s).
