1 (Whereupon, the following proceedings were had in the  
2 presence of the jury.)

3 MR. MCBRIDE: I have very brief redirect, Your Honor.

4 THE COURT: Yes.

5 REDIRECT EXAMINATION

6 BY MR. MCBRIDE:

7 Q Sir, Mr. Webb asked you about the websites. I'm going ask  
8 you some follow-up questions. Can you make contributions  
9 through PayPal on the websites?

10 A No.

11 Q Do the websites have any streaming?

12 A Like video?

13 Q Correct.

14 A No.

15 Q Do the -- can you listen to radio sermons or -- not  
16 sermons. Can you download sermons from the website?

17 A Yes, you can listen live or you can download.

18 Q All right. Can you download the books for free from the  
19 website?

20 A Yes.

21 Q Okay. Can you download or listen to radio interviews of  
22 Mr. Weinland from the websites?

23 A Yes.

24 Q When you're in congregation and listening to the sermon, I  
25 think you told us that it was not always live; correct?

1 A Correct.

2 Q Sometimes it's recorded; correct?

3 A Correct.

4 Q Do you hear the message of Jesus Christ from Mr. Weinland  
5 during his recorded sermons?

6 A Yes.

7 Q Do you know whether or not the college Mr. Weinland  
8 attended was accredited?

9 A I don't believe so.

10 Q You don't know or you don't believe it was?

11 A Well, I remember there was a process of going through that  
12 in the 1990s, but there was three campuses, so I don't know  
13 specifically. I know that he attended two of the campuses and I  
14 don't know if it was campus by campus on the accreditation part  
15 or if it was just the main Pasadena one, I don't know.

16 Q Thank you, sir. I appreciate that answer.

17 Now, Mr. Webb asked you about whether or not Mrs. Weinland  
18 provided fellowship and ministering to members. Has she ever  
19 provided fellowship or ministering to you individually?

20 A Yes.

21 Q Okay. And where did that take place?

22 A In person or on the phone.

23 Q So it's an effective and valid -- is it an effective and  
24 valid way to minister over the telephone?

25 A If you have something specific you need to address with

1 somebody, yes.

2 Q Very good. Tell me about the team concept and your role as  
3 an elder?

4 A Uh-huh. Well, an elder is a -- it's a spiritual office and  
5 just like a husband and wife become one when you're married, if  
6 one is ordained, they're a team and there's many times where you  
7 have to do things together. For example, if I had to meet with  
8 a female individual, you know, it would be improper for me to  
9 meet with her alone, so my wife would be there. There might be  
10 some things that I probably don't need to address or can't  
11 address from a female standpoint where she might have to do  
12 that.

13 Q Has your wife traveled with you to minister some --

14 A Yes.

15 Q -- with a member?

16 A Yes.

17 Q And has the church paid for that in the past?

18 A For a specific meeting with an individual, no.

19 Q Are there other occasions the church has paid?

20 A Yes. Like I was talking about the trips that we made  
21 during 2004 through 2008, like a trip to North Carolina to meet  
22 with a group down there and then one to Missouri and the elders  
23 meeting. And the meeting we had with the elders, just the four  
24 of us -- three of us elders in Las Vegas, she accompanied me on  
25 those trips.

1 Q Did she participate in the meetings?

2 A Yes.

3 Q What was her role in those meetings?

4 A Her role? Well, much like ours -- the rest of the elders  
5 is to listen and learn. And there would be -- sometimes there  
6 would be some discussion and questions and they participate in  
7 that as well.

8 Q Who decided what elders and their wives would attend that  
9 meeting?

10 A Which meeting are we talking about?

11 Q The one you were just talking about with your wife.

12 A Okay.

13 Q The trip --

14 A Ron.

15 Q Do you know whether or not that trip was income to you?

16 A Do I know if it was income?

17 Q Uh-huh. Did you think it was?

18 A No.

19 Q Your wife is a member of the church; correct?

20 A Yes.

21 Q Do you know whether or not -- outside of a contribution to  
22 help a member, do you know whether or not the church has paid  
23 for the travel of any non-elder or anybody -- somebody who's a  
24 member not holding another office?

25 A I'm not aware of that.

1 Q Mr. Weinland asked you about Jeremy. During the 2004 to  
2 2008 time frame, do you know where Jeremy lived?

3 A Who asked me that?

4 Q Mr. Webb.

5 A Oh, okay.

6 Q Did I say somebody else?

7 A Yeah.

8 Q I'm sorry. Mr. Webb.

9 A He was -- I don't know what exact timeframes, but I know he  
10 was living in Germany.

11 Q Do you know where he lives now?

12 A I believe in Germany.

13 Q One last question about Mrs. Weinland. And you testified  
14 earlier about women are now ordained ministers in the church;  
15 correct?

16 A Correct.

17 Q Does Mrs. Weinland have a role in the church?

18 A Yes.

19 Q What is that role?

20 A Well, she's under -- she's in charge of the ministry  
21 basically underneath Ron.

22 Q Okay. Is she a minister, an ordained minister?

23 A Yes.

24 Q What is her title or how would you describe it?

25 A Well, I would describe her as one of the two end time

1 witnesses, I would describe her as a prophet.

2 Q Does she ever give sermons?

3 A No.

4 Q When was she declared the end time -- one of the end time  
5 witnesses?

6 A Sometime after 2008.

7 Q And who declared her as such?

8 A Mr. Weinland.

9 MR. MCBRIDE: No more questions, Your Honor.
